RULES OF AWARDING ACCREDITATION BY ORGANIZERS

G2A ARENA DAFREAKZ MEET '19

ORGANIZERS

1. The organizers of the event are:

ACCREDITATION

1. The organizers will decide on granting accreditation based on the evaluation of the portfolio of the person submitting or the editorial office, which is represented by the applicant.

2. Applications for photo / video accreditation are accepted only through the form available on the website www.dafreakzmeet.com.

3. The number of accreditations is limited.

4. The accreditations granted are personal.

5. Accreditations are granted free of charge.

6. The accreditations are intended for journalists, photo journalists, image and sound operators as well as tv and radio journalists of mass media of international, nationwide and local character.

7. Accreditations are granted by the organizers of the event based on correctly completed accreditation form on the website www.dafreakzmeet.com. The application for accreditation will not be considered if false data is provided.
8. The accreditation form should be submitted by April 24th 2019 by 11:59 PM at the latest.
9. Sending the accreditation form is equivalent to a statement from reading and accepting the regulations for the media and the rules of the event and the reliability of the personal data provided.
10. Sending the accreditation form is tantamount to consenting to the processing of personal data by G2A Arena Exhibition and Congress Center of the Podkarpackie Voivodeship and Lemonade Studio Marcin Wójtowicz for the purpose of conducting the accreditation process.
11. Applicants will be notified of granting accreditation by e-mail or telephone no later than April 25st 2019 by 11:59 PM.
12. Accreditation allows free entry to the event area on April 27th – 28th 2019, participation in a artist's concert and entrance to the VIP area without additional benefits due to participants with a VIP ticket.
13. Accreditation does not entitle to take accompanying persons to the event.

REFUSAL OF GRANTING ACCREDITATION, ITS WITHDRAWAL AND PENALTY

1. The organizers reserve the right not to grant accreditation without giving a reason.
2. In case of a violation of these regulations and the rules of the event, the organizers have the right to withdraw or take away the accreditation.
3. Accreditations held by third parties and unauthorized persons are considered as invalid and they are subject to be taken away by representatives of the organizers or the organizers themselves.
4. The person applying for accreditation, at the time of granting it, bears legal responsibility in case of causing a threat to other people during the event and accepts the fact that the organizers do not bear any responsibility for acts or omissions of the accredited person during the event.
